

## COURSE BIDDING SYSTEM HISTORICAL RESULTS

The following table presents the historical outcomes of the UT College of Law Course Bidding System. Note that many factors determine the popularity of a particular course offering, and therefore these historical results may not reflect future outcomes. The Records Office does not provide predictions as to the number of points that will be necessary to get into any future course offering.

**Key:**

*Course Name* : Only courses with limited enrollment that have been oversubscribed in the past are listed. If a course is not listed, the bidding system has not been relevant to its enrollment.

*Cap Size* : The maximum number of students admitted to that course offering.

*Lowest Successful Bid* : The lowest bid entered by a student who was able to enroll in the course offering (not counting any later drop/add activity). "N/A" indicates that the course offering was not oversubscribed and the bids were ignored.

*Ties* : In some cases, more students will submit a lowest bid admitted than there are slots remaining in the course offering. In this circumstance, the Records Office resolves ties by random draw. This column indicates the number of tied bids over the number of remaining slots (i.e. "3/2" means three students tied for two remaining slots). An empty cell indicates that there were no ties for that offering.
